

Albert Villa was built *c.*1840-41, probably by William Morgan. The first occupier was Wardle Eastland Evans (1810-1884), a musician. Born in Margate, Wardle married a Cheltenham baker's daughter, Sarah Watcham, in 1838. Besides teaching, W.E. Evans was a skilled craftsman and inventor who did much to advance the of harmonium building in England. He designed the 'New English Harmonium', from 1843, producing many patents for improvements to the instrument. Henry Willis (1820-1901), later to become one of the greatest English pipe organ builders of the 19th century, worked with W.E. Evans in Cheltenham from 1842-45. Around this time (1844) Evans restored the pipe organ in St. Peter's, Winchcombe. Evans exhibited harmoniums at the Paris 1867 Exhibition, among others.



W.E. Evans moved to **Bath Buildings** (Bath Rd, junction with St. Luke's) in the mid-1840s, moving to **Sheffield** briefly in the late 1850s before settling in **London**. Here he developed and produced harmoniums **for Messrs Boosey & Sons**, as well as on his own account. **Evans** became bankrupt in 1867 and again in 1870, but undaunted he continued to bring out patents for 'improvements to harmoniums' until his death in **1884**.



While in Cheltenham, W.E. Evans, Leader & Director of the Cheltenham Philharmonic Society, taught a variety of musical instruments, available to hire or buy from a shop he had in Pittville Street. Evans had musical connections in Stroud as well. He also introduced Cheltenham to the Mainzerian system of singing. Prussian-born Joseph Mainzer (1801-1851) was a much respected composer, music journalist and pioneering music educator. He settled in Paris for a while, and was part of the revolutionary Association Polytechnique that offered free education to the working classes. His massed singing classes were a great success but aroused the suspicions of authorities, so Mainzer moved to England in 1841, where he taught across the country before settling in Edinburgh.

On arrival in England Mainzer had to teach himself to speak the language, and within a year he published Singing for the Million, written in English. Established music teachers and professors were often resistant to Mainzer's ideas, including musician and composer John Barnett (1802-1890), who published a pamphlet asserting 'SINGING CANNOT BE TAUGHT IN CLASSES'. John Barnett had retired to Cheltenham in 1841, where he was a singing-master, publishing his own works on systems of singing! (Barnett was the son of a Prussian Jew, Bernhard Beer, who had changed his surname on settling in England as a jeweller, which makes Barnett's rivalry and criticism surprising. – JW)

There was a large builder's yard next **to Albert Villa**, occupied by **William Morgan**, then **Winstone**, and later by members of the **Billings** family. **William Morgan** went bankrupt in 1843, and became an auctioneer. The yard, with lofts and cellarage, adjoining **Albert Villa** was the reason the properties were bought by the Brewery later in the century, for use as 'Stores'.


