OLAVE CHREIMAN, 1810-1886, CARVER & GILDER

Olave Chreiman was born in Soho, London, on 28 Jul 1810, son of George Chreiman and Hannah née Griffiths. His father, George Chreiman, was a stay and corset maker. In 1811 the family moved to Cheltenham, where Olave's youngest brother Henry was baptised on 20 Jan 1814. Over the following decades George Chreiman ran his corset business from various addresses along the High Street, at one time in partnership with his daughter Mary Elizabeth Cooke. One son, Thomas, trained as a carpenter and turner, while Olave became a carver, gilder and artists' colourman, establishing business in Albion Street by 1839. Olave and his father often swapped business premises with each other, according to the directories, and George also had premises in Albion Street and at 5 Pittville Street at different times.

In March 1840 Olave married Ann Inken and they went on to have 3 children together - Mary Ann, Elizabeth and George Thomas. In the 1840s Olave Chreiman became well-established in the Strand area of the High Street; he also owned a house in Alvin Street, Gloucester. Living above his shop, Olave took on apprentices to help in his production of ornate gilded frames. He also sold pictures and hosted the work of visiting artists and students.

In 1857 Olave bought property in Priory Terrace, Cheltenham, and the letting of these provided extra income for the family. In 1860 his first wife Ann died, leaving him with three young children. Olave married again in April 1862, to a young widow, Anna Maria King (née Nutt), who already had a daughter Mary Louisa. Olave and Anna Maria had a further two daughters - Eva Olivia and Amy Marion.

In 1867 Olave's father, George Chreiman, stay and corset maker, died at his son's residence, 406 High Street, aged 89. Olave's only son, George Thomas Chreiman, who had shown early artistic promise at his private academy, Hygeia House, in nearby Prestbury, followed his father into the carving and gilding business. Family relations must have been somewhat strained when in 1869 George T. 'ran off' to Winchcomb to marry his 17-year-old step-sister Maria Louisa King. Their first child was born two months later, and they had a total of 13 children. In 1871 the young family sailed to Melbourne, Australia, hoping the climate there would help George's asthma; the move proved unsuccessful and they returned home, one of their children, Bert, being born at sea on the trip home.

Olave's eldest daughter, Mary Ann Chreiman moved to London and set up an education establishment. She specialised in remedial gymnastics and became a leader in the field at a time when women it was unusual for women to consider taking physical exercise.

Olave Chreiman retired from business in 1875 and moved to live in his house, No.9 Priory Terrace. Son George continued the carving, gilding and frame-making business at 410 High Street for a while, but was unsuccessful and went into liquidation in 1879. He struggled on but at the end of 1882 he passed the business on to E. Banning of Bath Street. After this failure George and family emigrated to America, initially to Detroit. They settled in the Minneapolis area, where George worked as a carver and gilder for a range of companies. Some of his sons followed him into the trade.

Back in Cheltenham Olave had purchased another house, No.5 Crescent Terrace, for letting out, which added to his retirement income. Olave Chreiman died at No.9 Priory Terrace on 9 Feb 1886; his widow Anna Maria lived until 1914, and died at her home in Plymouth, Devon. One of Olave's younger daughters, Eva Grocock, née Chreiman, also emigrated to America and Canada, with her husband William Arthur Grocock in 1911; she died in Toronto in 1923.

There are almost certainly descendants of Olave Chreiman in America and Canada, and his pictures probably found their way there via his son George or his daughter Eva.

Thomas Ambrose Mountain was charged with breaking a pane of glass in the shop window of **Mr Olave Chreiman**, gilder, **415 High Street**. Mr Tompkins appeared for the defendant, and stated that he was pushed against the window by two girls, who ran off. It was perfectly accidental on his part, and he was blameless in the affair. It was at length agreed to give complainant 5s for the damage to the window, but he had to pay his own costs for the summons.

NOTE: Robert Bowyer (1758-1834) was a British miniature painter and publisher. His sitters included George IV, the aristocracy and the military. His two major endeavours were an illustrated edition of the Bible and David Hume's 'The History of England'. In the 1790s Bowyer opened a 'Historic Gallery' in Schomberg House, 82 Pall Mall, London. This venture collapsed in 1807 and was sold by lottery, followed by auctioning the paintings. On his death in 1834, **Mary Parkes**, a maid and shop assistant, inherited the business.

William Evans, apprentice to **Mr Chreiman**, carver and gilder, **High Street**, was charged with absenting himself from his master's service since the 8th inst. – **Mr Chreiman** stated that the prisoner had been his apprentice for four years and a half, during which period his conduct had been extremely irregular. He had received no premium with him, and his present wages were seven shillings per week. – On a promise of amendment, making an ample apology, and to pay expenses, the prisoner was discharged.

Cheltenham Examiner, Wed 7 Oct 1857 – CHELTENHAM CHAPEL



A meeting of friends and members belonging to this chapel was held on Tuesday evening in the vestry of the chapel, to consider the proposals laid before them by the trustees at the meeting on the Saturday previous, in reference to the continuance of public worship at that place. **Mr Chreiman** was called to the chair, and expressed the desire he had to see the chapel once more opened and prospering. ... Mr H. Workman moved, and Mr Ward seconded the following: "Resolved that this meeting will restrict the selection of a pastor from the ministers of the Free Church of Scotland, or of the Presbyterian Church in England, and that the congregation shall be connected with Birmingham Presbytery of the Presbyterian Church in England." — This resolution was agreed to unanimously, and numerous signatures were afterwards added to the memorial, after which the proceedings terminated.

Chreiman v. Clarke (a bankrupt) – In this case two points were reserved from the last court day for the consideration of the judge – first, as to whether the plaintiff was entitled to come in under a deed of assignment executed for the benefit of the defendant's creditors; and secondly whether, not having signed the deed, he was excluded from participating in the benefits to be derived from the defendant's estates.

Mr Marshall, for the plaintiff, said the defendant was formerly one of he masters of the College and received boarders, but not being his own pupils, he submitted that he was a trader, and that the plaintiff was entitled to recover his debt. – His Honour cited several cases in point, and decided to favour the plaintiff on the first point. He said he was relieved from giving any decision on the second point. ...

... Mr Marshall remarked that he never remembered any decision being given in that court as to who is a trader. The Judge said very likely not, but he could not go into that point at present. – The matter then dropped.

St. James's Chronicle, Thur 25 Aug 1859 - SALE of the LATE LORD NORTHWICK'S COLLECTION AT THIRLESTANE HOUSE

SEVENTEENTH DAY – The remainder of the treasures of art which adorned the walls of the principal gallery were yesterday dispersed by Mr Phillips, and, as might have been anticipated, attracted a vast audience. The prices, as the annexed statement will show, were beyond all precedent, and prove that a love for all that is genuine in art was never so predominant as at this moment: ...

... Lot 1,772. Canaletto: Scene on the Canal, Venice; a cabinet specimen; 43 gns. (Chreiman). ...

NOTE: – **John Rushout, 2**nd **Baron Northwick** (1770-1859) was an English peer, landowner and collector of art works. He died intestate and childness, and his collection was sold off; items from it appear in many major art collections around the world, and a **Northwick** provenance is of enormous value, not least in the Sale Room. The great 21-day sale, with other smaller sales in 1860, was conducted by the then rival to Christies – Phillips – at **Thirlestaine House** in Cheltenham. It was a major international event which has gone down in history.

... The house, No.1 St. George's Square, in the occupation of Mr Wilks, was bought by Mr Chreiman for £320.

Cheltenham Examiner, Wed 13 Mar 1861 – A MODEL APPRENTICE

James Henry James, a very respectable-looking boy, was charged with unlawfully absenting himself from the service of Mr Chreiman, carver and gilder of High Street, to whom he was apprenticed. — Mr W. Boodle appeared for the complainant and explained that defendant was an orphan, and had been apprenticed by his aunt to Mr Chreiman. He had turned out very badly, and this was the third time he had run away.

On Saturday last Mr E. Boodle (Relieving-officer) went to **Mr Chreiman** as someone had called on him to say that **Mr Chreiman** requested to see him in a hurry, a circumstance having arisen through which he urgently need relief from the parish! (Laughter.) Upon making enquiries he found that his apprentice (the defendant) was the offender, and in a moment of irritation gave him a box on the ear. The lad had gone away and had not since returned to his work. He had written an insolent apology (!) in which he admitted sending Mr Boodle, and hold his master to kame haste with any punishment, and threatened him that he would always rebel against a blow.

The complainant, upon oath, corroborated Mr Boodle's statement. He was particularly exasperated with the lad, as he not only sent the relieving-officer, but when accused of doing so, denied it repeatedly. It was the first time he had struck him, and should not have done so now but for the very great provocation he had received. The indenture was signed Feb 11th 1860, and bound the lad apprentice for five years. The lad had turned out very badly, and both witness and the aunt had tried everything they could to make him act differently.

In reply to the Magistrates, **Mr Chreiman** said that as the lad was an orphan he would try him once more upon his promise to act better for the future, but he was afraid his promise was worthless. – Chairman (to defendant): If **Mr Chreiman** brings you up again and a case is proved against you, we shall try what effect our sending you to prison will have upon you. – The defendant was then sent back to his master's, orders being that the office expenses should be deducted from his wages.

Cheltenham Mercury, Sat 7 Sep 1861 – POLICE COURT – SEWERS RATES

Olave Chreiman was summoned for the non-payment of 18s district sewers rate. **Mr Chreiman** said that he had paid a previous rate, and then appealed, and the Commissioners decided to reduce the rate three-fourths, but as he had paid the amount, they refused to refund the portion he had paid in excess.

The Clerk – It is very unfair. Mr Forty – I shall press for the rate.

The Bench made an order for the payment, expressing an opinion that it was a very hard case.

John Pye, carver and gilder, and Ann Rea, of 39 St. Paul's Street North, were charged with stealing, within the last three months, from 406 High Street, a quantity of articles, value £5, the property of Olave Chreiman, carver and gilder. – Mr Boodle for the prisoners. – Mrs Chreiman said: The female prisoner has been in my service from 1st April to 23rd June last, as general servant. Prisoner Pye is a carver, and has been in my husband's employ for more than half a year. I have looked at the articles produced by Sergt. Wiggett; they are my husband's property. They consist of a cameo brooch, scent bottle, locket, plaid dress, flannel petticoat, cotton ditto, black shawl, 3 tablecloths, 3 table napkins, 3 nightgowns, 4 pairs of drawers, pillow slips, 3 baby's shifts, 6 pocket handkerchiefs, 2 table covers, 5 night caps, towel, silk veil, 2 doyleys, sheet, 6 child's napkins. I can identify the articles, and some of them have my mark upon them. They were safe in my drawers during part of the time Rea was with me, and she had access to them. I first missed some of the articles a fortnight after she had left my service. – By Mr Boodle: The whole of the articles stolen are what would be used and required by a female; there would be nothing among them useful to a man. Pye merely passed through the house to go to the workshop, and had no access to that part of the house where these articles are kept. Rea left me for the ostensible purpose of going to nurse her grandmother. I was not aware until last night that she was in the town. I understand she has been living with the male prisoner.

Caroline Crowler, a married woman, living at **39 St. Paul's Street North**: I know the prisoners; they have been lodging at my house during the last two months. They lived together as man and wife, and I only knew them by the names of **Mr and Mrs Pye**. They brought their goods when they came together in a fly. Have seen some of the articles in question, as they have bene hanging on the line after having been washed. – By Mr Boodle: **Pye** came first to inquire about the lodgings; he said he would not take them until he had consulted his wife. The luggage consisted of two boxes, but never saw them open until yesterday, when the policeman was there.

P.S. Wiggett said that on the 11 inst., he received information of the robbery from **Mr Chreiman**. Yesterday afternoon he went to **Mr Chreiman's** shop, where he found the prisoner **Pye** at work. In **Mr Chreiman's** presence he asked **Pye** where he lived. He hesitated some time, but at last stated. They started in a fly, accompanied by **Mr** and **Miss Chreiman**. When they had arrived at **St. Paul's Street North** prisoner stopped the fly, and witness demanded to know where he lived. He declined to say unless he was allowed to get his things away. Witness consented, and watched prisoner enter **No.39**. He followed in a few minutes, and found them altogether in an upstairs room. **Rea** appeared to have fainted, and was sitting in a chair in a state of apparent unconsciousness. Witness spoke to **Rea**, but she made no answer. **Pye** then showed him **Rea's** boxes, remarking at the same time "I don't know what is in them". Being unlocked witness opened them. One contained articles belonging to **Rea**; the other some of the stolen property. The remainder was found in a downstairs apartment occupied by the prisoners, and on a line in the backyard. The prisoners were then conveyed to the police station. — In the course of Mr Boodle's cross-examination of this witness, the female prisoner was seized with a hysterical fit, and fell heavily upon the floor of the dock. She was removed and restoratives administered, and after a delay of a quarter of an hour, she recovered sufficiently to be brought into court.

Mr Chreiman deposed interrogating **Pye** on the previous afternoon as to his place of residence. **Pye** refused to tell, angrily remarking that he had been watched. Witness persisted in repeating the question, telling him that if he continued to withhold the information he would be delivered into custody. He consented after a quarter of an hour's hesitation, if allowed first to remove his rifle and other clothes, and promised to touch nothing else. Witness, at this time, had mentioned that he had lost a valuable brooch. **Pye** said he knew nothing of that, but he had noticed something marked "**M.A. King**".

It was at last arranged that he should accompany witness and his daughter. Prisoner admitted previously that he was a married man, but that he was living with **Rea**. On arriving at the prisoner's lodgings they saw several articles which they knew to be part of the stolen property. A nightdress, which he could particularly identify, was lying upon the bed; it had evidently been worn. When they entered the room **Rea** was lying upon the bed apparently unconscious. After a time she recovered and said "I never was a thief, **Mr Chreiman**, before I came to your house; and I did it to get a home".

Cross-examined: **Pye** is my foreman, and I placed great confidence in him. I told him I wanted his address because I had heard the day previously that he was married to **Ann Rea**. He said he would not give it as he had been watched; he would have knocked the young rascal's head against the wall for following them. Did not believe that **Pye** took the things, but believed that **Rea** had them. The names upon the articles have been cut out, and pieces inserted.

Mr Boodle said there was no tittle of evidence against **Pye**; the articles were not found in his possession, and any opportunity of knowing them to belong to anyone else was carefully concealed by **Rea** cutting out the names. He therefore hoped the magistrates would discharge him. – Mr Barnett said it was impossible for a man to be living with a woman for some months without knowing whether the articles she had were really her own. At least, they could not separate the prisoners in the charge. – The depositions were then read over, and the prisoners, reserving their defence, were fully committed to take their trial at the Quarter Sessions. Bail was applied for, and refused.



Cheltenham Examiner, Wed 31 May 1876 - THE MISSING ROBERT NUTT - (uncle of Maria Louisa Chreiman)

Before the Supreme Court of Appeal, on Tuesday last, the extraordinary Life Assurance case of **Edmonds** *v*. **The Prudential Life Assurance Company** came on upon appeal. – It will be remembered that the circumstances and facts laid before the Court, at the trial of the action at the Croydon assizes in the summer of last year were of a remarkable character, and were watched with considerable interest. We will however briefly allude to some of the leading features.

Robert Nutt was a tailor at one time in a good position at Cheltenham, but neglect of business and other causes, originating through the loss of his wife in childbirth, launched him into a state of pecuniary difficulty. To aid his struggle to keep on business he borrowed money from an insurance office, afterwards amalgamated with the Prudential on the security of a bond, and a policy for £400 on his own life. Nutt's difficulties increased rather than lessened until his ruin. The insurance policy was purchased by the plaintiff (Edmonds) in 1865, on the occasion of the bond debt being discharged by Nutt's sureties, two tradesmen of Cheltenham, and who were connected by marriage with his family. Shortly afterwards Nutt left the town, leaving his children behind, and never returned. It was supposed that he enlisted in the army, and though attempts to trace him proved abortive, he was heard of at Aldershot in the following year.

Seven years having elapsed from the time that he was at Aldershot, the plaintiff, who had kept the policy afloat, relying on the legal assumption that if a man has not been heard of for seven years he must be regarded as dead, claimed the sum assured by the policy, and the return of some of the premiums. At this juncture **Mr Edmonds** received, in reply to advertisements for the discovery of **Nutt** if living, information that a tramping tailor, who had worked at Rotherham, in Yorkshire, and said he had seen better days, had been drowned whilst bathing in the river Don, and that his description tallied with the advertised one of **Nutt**. The drowned man had systematically kept his surname secret from those with whom he was brought into contact, and was only known by the familiar title of "**Bob**". Several witnesses testified that a photograph, admitted by all parties to be a good portrait of **Nutt**, and which was handed to the jury, was that of the man who had lost his life in the Don.


The defendants, not satisfied that **Nutt** was really or legally dead, did not comply with the plaintiff's demand of payment, and he brought the action against them, which was tried at Croydon before Lord Chief Baron Kelly and a special jury. The plaintiff based his claim on the two grounds – first, that the drowned body was that of **Nutt**; and secondly that he had not been heard of for upwards of seven years, if it was some other person whose life had been sacrificed in the Don. On the other hand the defendants produced numerous witnesses, whose testimony went to show such discrepancies as to the colour of the hair, height, age, &c., that the jury, long before the termination of the case, were satisfied the drowned tailor and **Nutt** were two different persons.

Re. the other ground on which the plaintiff founded the action, Mrs Chreiman, wife of a carver and gilder at Cheltenham, and a favourite niece of Nutt's, deposed that while in Elizabeth Street, a busy and crowded thoroughfare in Melbourne, some two years previously, a man passed her whom she recognised as her missing uncle, but she admitted that she did not speak to him, nor did she or her husband take any step afterwards to satisfy themselves, or to discover his whereabouts. She, however, stated that she had mentioned the incident in a letter to her mother, also resident at Cheltenham. The mother (Olave's wife) also swore that she had received such a communication, which was not forthcoming before the jury, who, prior to the conclusion of the trial, which lasted several days, intimated that they were not satisfied with the younger Chreiman's evidence. In his summing-up address the Lord Chief Baron did not, as alleged, clearly direct the jury to consider whether or not the statement of Mrs Chreiman was entitled to credibility, but led them to understand that because Nutt had been "heard of" by his Cheltenham relatives within seven years they were to act upon the assumption that he was living. To this ruling a bill of exceptions was tendered by Mr Edmond's counsel, and as the jury found for the defendants, it now came on for argument. ...

... The Master of the Rolls ... said the substantial question was simply whether the learned Chief Baron did or not say to the jury that it was for them to consider whether **Mrs Chreiman** was mistaken or not in thinking she had seen her uncle. It appeared him that the fair effect of the summing up was that, whether she was mistaken or not, whatever conclusion they came to, they were bound to presume that the man was not proved to be dead. ... His conviction was that the Chief Baron ought to have left the question of a mistake on the part of **Mrs Chreiman** to the jury, and that therefore there must be a new trial. – Lord Coleridge said that if **Mrs Chreiman** was believed, she rebutted the plaintiff's evidence of **Nutt's** death, but if she was not believed, the presumption was where it was before – in favour of the plaintiff. The whole evidence depended upon the question of the credibility of that witness. His Lordship was of opinion that the Chief Baron properly directed the jury as to the law of presumption. It did not seem to have been imputed that **Mrs Chreiman** perjured herself, but simply that she had not been in a position to give satisfactory evidence, and that she might be and probably was mistaken. ...

... Mr Baron Pollock said, not without some hesitation, he had come to the conclusion that there ought to be a new trial *de novo*. ... It might have been that the jury, upon the particular words used by the Lord Chief Baron, might have though that they were bound, by reason of the relatives having "heard" something at Cheltenham, to act upon the question of presumption. The case was one of great misfortune, and must go down for a new trial. – A new trial ordered accordingly.

In the House of Lords on Friday the appeal **Prudential Assurance Company** *v.* **Edmonds** was heard. This was originally an action by **Mr Edmond Edmonds** to recover from the above company the amount of a policy of assurance on the life of a person named **Nutt**. In proof of death it was shown that **Nutt**, who had been in business in **Cheltenham**, became drunken in his habits, and left that place in **1867**; that he afterwards worked as a tailor at Aldershot, but was dismissed for dissipation, and that his relations had received no communication from him since he disappeared from Cheltenham. On the other hand there was the evidence of a **Mrs Chreiman**, a niece of **Nutt's**, that either late in **1872** of early in **1873** she had seen a well-dressed man, whom she recognised as her uncle, in a crowded street in **Melbourne**, Australia; but that before she could address him he was lost in the crowd.

The Lord Chief Baron held that there was no evidence on which the presumption of death could be based, but the Court of Appeal, on a bill of exceptions, decided in favour of **Edmonds**, the applicant. The Company appealed. Their Lordships were equally divided in opinion. The result is that the judgement of the Court below stands. – The appeal was dismissed without costs.

Morning Post, Fri 16 Mar 1888 – PHYSICAL CULTURE OF WOMAN

A paper was read on the physical culture of woman by Miss M.A. Chreiman in the Parkes Museum of Hygiene, Margaret Street, last night. Sir Douglas Galton presided. — The lecturer contended that on the proper education of girls, both as regards their physical and mental powers, depended either the advancement or deterioration of our race. It seemed a paradox that we should be constantly employed in developing horses and dogs, and rearing and transplanting flowers and plants, and yet so persistently neglecting ourselves. The conditions of a healthy existence were pure air, warmth, and the exercise of the mental and physical powers by work and play. It was the mind, and not the other vital organs, which regulated life, and it was necessary that those who had the training of childhood should form a just estimate of the child's character and physical strength or weakness. On this basis alone should the training be conducted. A proper course led not only to a healthy body and vigorous mind, but to beauty of person. Beauty was one of those things which everyone had a right to ask for, because it was one of those things conducive to social happiness.

At the close of the lecture a number of school girls went through a series of calisthenic exercises, comprising bar, dumb-bell, Indian club, and Spanish musical drill, to the great satisfaction of the audience. - A vote of thanks closed the proceedings.
