



Cheltenham Local History Society

Cheltenham Local History Society encourages all members and interested local historians to publish their original research on Cheltenham in the Society's *Journal*, for the benefit of members and other readers.

These notes cover the key issues associated with **Copyright** to consider when preparing an article for inclusion in the CLHS *Journal*. They provide guidance to ensure that the rights of the owners of copyright material cited or included are protected, likewise the rights of the author in the text of their article and of the Society in the integrity of the *Journal* as published.

It is the responsibility of the Society to ensure that it complies with copyright law in all of its publications.

While this might seem daunting for a prospective author, the key is to have obtained written permission to use material (images in particular) from the copyright owners, and this is generally relatively straightforward. The Society has a copyright consultant as one of its members. If further advice is needed, please ask the Editor.

An article must be the result of the author's own original research; any reference to or short quotation from another author's published works being clearly acknowledged and attributed in an end-note.

Permission to use any image or to quote extensively must be obtained by the author, in writing, from the copyright owner of quoted images or text, or if out of copyright by the institution holding the material. This permission should be both for the initial hard-copy publication of the *Journal* which will also be stored digitally, and for its up-loading to the Society website for world-wide access after, approximately, five years. Please note that generalised or verbal permissions are not acceptable. Permissions must be specific to the article for the above purposes and be in writing. A suggested form of wording can be found as Appendix 1 at the end of these notes.

A condition of publication is that authors sign a Copyright Permission form which states that they have obtained written permission, thereby indemnifying the Society. On occasions the Editor might ask an author to show proof of having obtained, in writing, the necessary permissions or licence from the copyright owner. A copy of the form can be found as Appendix 2 at the end of these notes, but for reference only – one for signing will be provided once an article has been accepted and initially set by the Editor.

The original copyright owner retains copyright in the images or long quotations used and not the author of the article. However, the author has copyright in their article, along with any images or quoted text created by themselves, and gives the Society permission to publish it in both hardcopy and digital format, and to store it digitally, by signing and returning the Copyright Permission form; and the Society asserts its copyright to the *Journal* as a published whole.

Any request for permission to quote, cite or otherwise use an article received by the Editor or the Society, for a purpose other than storage or publication as mentioned above, will be directed back to the author, if the Society is satisfied that the request will not breach its own copyright in the publication.

Authors might like to note:

- A majority of images (paintings, illustrations, postcards, maps, etc., and photographs of these images) are likely to be in copyright because copyright lasts for 70 years from the death of the author/artist/illustrator/photographer.
 - Images available across the internet are mostly in copyright and not in the public domain - even though they are publicly accessible.
 - Unpublished documents created before 1969 are in copyright until 31 December 2039. Unpublished documents created after 1 January 1969 are in copyright for 70 years after the work was produced.
 - Photographs of material may still be in copyright, even though the material itself is out of copyright. Please ensure such photographs are cleared for use and the correct acknowledgement of source and reference for the photo are given, as well as the caption desired.
 - Material that is entirely out of copyright will still require the written permission of the holding body for the uses as previously stated.
- Citation of material held in archives, private collections, photographic libraries or museums will all require both written permission and need a specific reference. When published in the *Journal*, each image in an article will show below its caption both the copyright owner and the source with reference. Permission will be implied, supported by the signed Copyright Permission form. Occasionally permission will be explicitly stated, for example where the image or text is out of copyright or where the creator of an image has died and permission for use is given by their estate or heir.
- Use of Ordnance Survey maps require a licence and the licence number has to be printed beside the image as a reference. Ordnance Survey strictly enforce their requirements for licence permissions to use.
- Some copyright owners may ask for a fee for reproduction. It is likely that this fee will be waived if the copyright owner is aware that the print copy of the *Journal* is a non-profit making publication for a registered charity, has a low print run of about 350 hard-copies and a territory largely restricted to the UK. The distribution of the *Journal* is to members of the Society as part of their membership fee. Copies are offered for sale to non-members at Society meetings. The offer of a copy of the *Journal* in exchange for the use of material is often sufficient payment.

The Editor does not have a budget for any fees or expenses incurred in the production of any article which might, on occasions, mean that a desired image might not be able to be used.

NB Copyright owners should however be made aware that the *Journal* will be stored digitally and will be up-loaded to the Society's website after approximately five years, giving world-wide access. They need to have given written permission for these additional uses.

Appendices

1: A suggested form of wording that authors may wish to use when seeking written permission to use an image or extended quotation in their articles from copyright owners.

I understand that the article containing this material will first be published in print for distribution to members of the Society as part of their subscription, with a few initial copies for wider sale (and provision for later printing-on-demand); will be archived digitally by the Society; and may be subsequently uploaded to the Society's website providing worldwide access.

Should the Society or author(s) receive a request for use or reproduction of the article for any other purpose other than those outlined above, if the Society approves the request, then the author should seek further permission from me, in writing, for such use or reproduction of the above named material.

COPYRIGHT PERMISSION FORM

For the submission of articles to the Journal, Newsletter, website

agree the following conditions.

1. I am / We are the author(s) of the above named article and am / are therefore the copyright owner(s) of the text submitted, as edited for publication.
(In the case of joint authors, both authors should sign below.)
2. The author(s), as copyright owner(s) of the text of the article, understand that the material will be published first as a hard copy for distribution to the Society's members, with a few initial copies for wider sale (and provision for later printing-on-demand); will be stored digitally by the Society; and will, after approximately five years, be uploaded to the Society's website providing worldwide access. Therefore, by submission, permission is given by the author(s) for the material to be used by the Society for these purposes.
3. The author(s) declare that any material used or copied from another source, either text or image, has had permission granted to the author(s), in writing, for its use in the article to be published first in print in the above publication, stored digitally and subsequently published on the Society's website.

The author(s) agree to produce, on request from the Editor, these written permissions from copyright owners of material so used or copied, and thereby to indemnify **Cheltenham Local History Society** from any liability for infringement of copyright.

4. Requests for permission to reproduce any part of the submitted article, other than for the above uses, will be referred to the author(s) after, and only if, permission has been granted by the Society. This is because the Society has copyright in the *Journal* itself in which the article appears. In this situation, the author(s) will probably need to obtain fresh permission from the copyright owner(s) of any material used or copied. That is their responsibility.
